(DRAFT) Burgh and Tuttington Parish Council Co-option Policy

The co-option of a Parish Councillor occurs when a casual vacancy has arisen on the Parish Council and no poll (by-election) has been called.

To ensure that a fair and transparent process is undertaken, the procedure below will be followed by Burgh and Tuttington Parish Council.

CONFIRMATION OF CO-OPTION

On receipt of written confirmation from the Electoral Service of the District Council, the casual vacancy can be filled by means of co-option.

In this instance the Clerk will:

- a. Advertise the vacancy for 4 weeks on the Council notice boards and website.
- b. Advise the Council that the co-option policy has been instigated.

Members may point out the vacancies and the process to any interested persons.

ELIGIBILITY

Although there is no statutory requirement to do so candidates will be requested to

- a. Provide information about themselves by way of completing a short application form. A copy of the application form is attached.
 - b. Confirm their eligibility for the position of Councillor within the statutory rules. A copy of the eligibility form is attached.

APPLICATIONS

Following receipt of applications, the next suitable council meeting will have an agenda item 'To receive written applications for the office of Parish Councillor and to co-opt a candidate to fill the existing vacancy'

Copies of the applications received will be circulated to all councillors by the Clerk, at least 3 days prior to the meeting of the Council where the co-option will be considered. All such documents will be treated by the Clerk and councillors as Strictly Private and Confidential.

MEETING

At the meeting, each candidate will be allocated five minutes to address members introducing themselves and to give information on their background and experience and explain why they wish to become a member of Burgh and Tuttington Parish Council.

Where the Council wishes to discuss the merits of candidates and inevitably their personal attributes, this could be prejudicial and the council will resolve to exclude the members of the press and public.

VOTING

Voting will be according to the statutory requirements, in that, a successful candidate must have received an absolute majority vote of those present and voting. If there are more than two

candidates for one vacancy and no one, at the first count, receives a majority over the aggregate votes given to the rest, steps must be taken to strike off the candidate with the least number of votes and the remainder must then be put to the vote again; this process must, if necessary, be repeated until an absolute majority is obtained. The Council is not obliged to fill any vacancy. Even if the Council invites applications for co-option, it is not obliged to select anyone from the candidates who apply. However Burgh and Tuttington Parish Council is mindful that it is not desirable that electors be left partially or fully under-represented for a significant length of time. This does not contribute to effective and efficient working of the Council with insufficient councillors to share responsibility and partake in the decision making processes or achieve meeting quorums without difficulty.

CONCLUSION

After the vote has been concluded, the Chairman will declare the successful candidate duly elected and after signing a Declaration of Acceptance of Office they may take their seat immediately.
